## WHO CAN BE AN ACTIVE MEMBER?

Any person, firm, cooperative, LLC or corporation engaged in the marketing or distribution of motor fuel, heating fuel or alternative fuel energy and retail convenience store and vehicles products and services shall be eligible for membership in FUEllowa.

## DUES

Dues are based on the total Iowa (WHOLESALE and RETAIL) fuel gallons sold annually. Including but not limited to gasoline, diesel, ethanol, biodiesel, LPG, aviation, lubes, etc.  
**NOTE: 50 percent of FUEllowa dues may be deductible as a business expense.**
